Policy Statement

Emergency Response Procedures

1- Emergency Notification and Activation:

2- Communication:

- The crisis coordinator will ensure timely and accurate communication with staff, students, parents, and relevant authorities.
- Communication channels include SMS alerts, emails, phone calls, and official social media platforms.

3- Emergency Evacuation and Sheltering:

- Specific procedures for evacuation and sheltering will be established based on the nature of the crisis.
- Evacuation routes, assembly points, and shelter locations will be clearly marked and communicated to all stakeholders

4- Medical Assistance:

- Trained staff members will provide immediate first aid and medical assistance to those in need.
- Emergency medical services will be contacted if necessary.

5- Security Measures:

- Security personnel will collaborate with local law enforcement agencies to address security threats and maintain order.

6- Parent Communication and Reunification:

- Parents will be informed about the crisis through official communication channels.
- Reunification procedures will ensure students are released only to authorized individuals after proper identification.

7- Continuity of Learning:

- Plans for remote learning, if applicable, will be activated to ensure minimal disruption to students' education.
